The Foundation operates an ongoing campaign aimed at preserving the legacy of Eisenhower. This program is intended to directly achieve the organizational mission of honoring and championing the relevance today of the life and leadership of Dwight D Eisenhower through a direct mailing program that provides information about President Eisenhower and the programs and events of the library and museum.

IKE educational activities transform primary sources from the Eisenhower presidential library and museum into innovative, participatory experiences for K-12 students. These informative and entertaining programs provide students with a greater understanding of Eisenhower's roles as supreme allied commander during World War II and as the 34th President of the United States - and ways in which his legacy relates to students today. The Foundation facilitates onsite programs for school groups and offers a website that provides teachers engaging lesson plans, online resources, primary sources and interactive student activities. During the 2020-2021 academic year, 15,460 students/participants and 948 teachers/adults participated in 715 IKEducation programs via IKE Online (virtual) and IKE Express (school outreach).
